SAGE Counseling will lower the intake fee to \$40.00 for clients that attend their first appointment. This is an incentive for clients to remain compliant with the terms of probation and enroll into treatment. To be eligible for the discounted rates clients must contact SAGE within 5 days from the date of this referral and attend their first scheduled appointment. Clients that miss, cancel, reschedule or contact SAGE after the 5th day will be required to pay the full fee of \$50.00. Screening fees are a flat rate of \$70.00. Clients that miss, or reschedule their screening 2 times will be subject to a rescheduling fee.

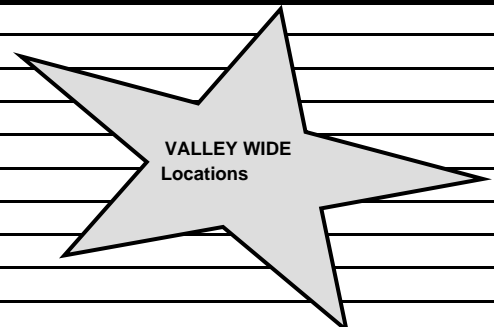
